the undersigned, being a financial Member of the Chevrolet Car Club of Vic. Inc., (“the Club”) hereby declare that I:

1. Have obtained a current copy of *The Victorian Club Permit Logbook Scheme* handbook**;
2. Have read and fully understood the contents of that publication;
3. Will only use or permit to be used, the unregistered vehicle described above, and issued with a valid permit for its restricted use, in accordance with the requirements specified in that publication (as may be amended);
4. Will present this vehicle on at least **one** occasion in a six-month period (for 45-day Permit), or **two** occasions in a twelve-month period (for a 90-day Permit), at any event listed in the Club’s Calendar of Events and present this vehicle’s log book on that occasion for endorsement by any current committee member or some other person specifically appointed for that purpose on that occasion as verification of the vehicle’s attendance.

(NOTE: Exceptions from this requirement will only be granted in writing by the Committee and signed by an office bearer of the club after minuting that exception in the Committee’s deliberations at any Committee meeting of the Club after presentation of a written application with a valid reason acceptable to the Committee of Management.);

5. Will remain a financial member of the Club at all times this vehicle in on Club Permit.
6. Will notify forthwith the Chevrolet Car Club of Vic. Inc. of the Permit N° and expiry date of the permit if not available on the date shown below;
7. Will notify forthwith the Chevrolet Car Club of Vic. Inc. in the event of:
 - (a) the disposal by sale or otherwise of the above vehicle,
 - (b) the vehicle becoming fully registered,
 - (c) the Permit being surrendered to VicRoads for whatever reason.
8. Must own at least one club-eligible vehicle before the club will accept any further non-club-eligible vehicles for acceptance onto the Club Permit Scheme.

VicRoads will be notified of any Club Permit vehicle for which a declaration has not been received by the Club in accordance with the above conditions for revocation of the permit. VicRoads will also be notified in the event of a member becoming unfinancial.*
